

Terms and Conditions – Kingswim & ELC, One Week Free Childcare Promotion

The Promotion

1. “We”, “Us”, “Our” and “Promoter” are, collectively:
 - a. YMCA Aquatic Education Ltd (ABN 88 151 552 322) of 2 St Catherine’s Court, Mornington, telephone (03) 5975 0777 (**Kingswim**); and
 - b. Victorian YMCA Community Programming Pty Ltd (75 092 818 445) of 502/990 Whitehorse Road, Box Hill, telephone (03) 9403 5000 (**YMCA Victoria**).
2. These terms and conditions (**Terms**) govern the 'One Week Free Childcare' promotion being run by the Promoter (**Promotion**).
3. Participation in the Promotion is deemed acceptance of these Terms (including any subsequent variations to these Terms as provided for in clause 11).
4. Subject to these Terms, all Eligible Persons will be entitled to receive up to one (1) week (equating to the maximum operating hours of the particular Participating Centre for a week (usually sixty (60) hours)) of free childcare for an Eligible Child at a Participating Centre (**Offer**).
5. The Offer is available to be redeemed at the following YMCA Victoria Early Learning Centres (**Participating Centres**)
 - a. Derrimut YMCA Early Learning Centre, 30 Lennon Parkway, Derrimut VIC 3026;
 - b. Epping North YMCA Early Learning Centre, 355 Harvest Home Road, Epping North, VIC 3076;
 - c. Mernda YMCA Early Learning Centre, 2 Goulburn Street, Mernda VIC 3754;
 - d. Wyndham Vale YMCA Early Learning Centre, 1 Paramount Boulevard, Wyndham Vale VIC 3024;
 - e. Taylors Hill YMCA Early Learning Centre, 12 Park Lane, Taylors Hill VIC 3037; and
 - f. Narre Warren Early Learning Centre, 4-12 The Avenue, Narre Warren South, VIC 3805.

Eligibility

6. The Promotion is open to parents/guardians:
 - a. who are listed on Kingswim's file as the parent/guardian of a child enrolled and participating between 1 July 2024 and 31st March 2025 in group or private learn to swim lessons at any Kingswim centre in Victoria (**Eligible Child**); and
 - b. whose children have never (outside of the Promotion) been enrolled or attended any YMCA Victoria Early Learning Centre in Victoria; and

- c. who have enrolled their Eligible Child in child care at a Participating Centre prior to 31st of March 2025 (**Enrolment Date**); and
- d. who have paid for their Eligible Child to participate in child care at a Participating Centre starting prior to the 30th of June 2025 for no less than 1 day per week over 4 consecutive weeks totalling no less than 48 (forty-eight) hours of care (**Paid Period**); and
- e. who are not otherwise ineligible or excluded under these Terms,

(Eligible Persons).

- 7. Employees and directors of the Promoter and their immediate family members, retailers, suppliers, associated companies and agencies associated with the Promoter are ineligible to redeem the Offer (whether or not they meet the criteria outlined in clause 6 above). For the purposes of this clause an “**immediate family member**” includes any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

Terms of the Promotion

- 8. The Promotion is subject to the following Terms:
 - a. the Offer can only be redeemed during a single week (Monday to Friday (inclusive)) and cannot be split over multiple weeks;
 - b. the Offer is non-refundable, non-transferrable and not redeemable for cash or credit;
 - c. the Offer is only valid for long day care and integrated kinder and not any other services or programs offered by YMCA Victoria at Participating Centres (including but not limited to before school programs, after school programs, school holiday programs and sessional kinder);
 - d. the Federal Government’s Child Care Subsidy cannot be received for the days of child care that are covered by the Offer;
 - e. the Promotion is not valid in conjunction with other offers, unless approved in writing by the Promoter;
 - f. redemption of the Offer must commence within 3 (three) months of the completion of the Paid Period (**Offer Window**); and
 - g. the Eligible Child must be five (5) years or under at the Enrolment Date.

Promotion subject to availability

- 9. Access to the Paid Period and subsequently the Offer is subject to capacity limits and availability. If We are unable to provide the Offer at the particular Participating Centre that the Eligible Person wishes to receive them during the Offer Window, We may attempt to find suitable alternative dates for the Offer to be received. Eligible Persons acknowledge and agree that such re-booking will be at Our discretion and may not always be possible. If the

Offer is not able to be redeemed by any Eligible Persons during the Offer Window then We will extend the window in order to enable you to receive the benefit of the Offer.

Multiple Entries

10. Only one entry per Eligible Child is permitted and any further entries by either the same or different Eligible Persons in respect of the same Eligible Child will be deemed invalid. Where a parent/guardian has more than one Eligible Child and is an Eligible Person with respect to each Eligible Child, that Parent/Guardian is entitled to receive the Offer in respect of each Eligible Child.

Legal

12. The Promoter reserves the right, at any time, to verify the validity and eligibility of enrolments and enquires (including a child's identity, age and place of residence) and to disqualify any entrant who submits an enrolment that is not in accordance with these Terms or who tampers with the entry process or engages in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of this Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
13. Nothing in these Terms limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Competition and Consumer Act 2010* (Cth) or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**").
14. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including in negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any part of the Offer that is not redeemed, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any tax liability incurred by a participant or entrant; (e) taking and/or use of the Offer; or (f) the Promotion.
15. The Promoter will use the personal details that have been provided to the Promoter when the relevant child was enrolled for lessons at Kingswim. If a child's personal details (including email address) have changed since they enrolled the child in swimming lessons, it is the parent/guardian's responsibility to provide the Promoter with updated details. The Promoter does not accept any responsibility for incorrect details resulting in a particular individual not being able to redeem the Offer.

General

16. In the event of war, terrorism, state of emergency, disaster or (without limitation) any other event outside the Promoter's reasonable control that would reasonably prevent the Promotion from occurring or the Offer from being granted or used, the Promoter is entitled to cancel, terminate, modify or suspend the Promotion subject to written direction from any relevant regulatory authority if required.
17. If for any reason the Promotion is not capable of running as planned (including but not limited to) technical failures, unauthorised intervention, fraud or any other causes beyond the Promoter's control which corrupts or affects the administration, security, fairness, integrity or proper conduct of the Promotion, the Promoter is entitled in its sole discretion to cancel, terminate, modify or suspend the Promotion subject to written direction from any relevant regulatory authority if required
18. As a condition of accepting the Offer, the Eligible Person must sign any legal documentation as and in the form required by the Promoter and/or offer in their absolute discretion, including but not limited to a legal release and indemnity form.

Privacy

The Promoter collects personal information in order to conduct the Promotion and may, for the above purposes, disclose such personal information to third parties, including but not limited to agents, contractors, service providers, and as required, to regulatory authorities. Entry into the Promotion is conditional on providing this information. Personal information may be used for marketing purposes in the future. Entrants should use the system embedded within our electronic communications if they wish to opt out, access, update or correct information to the Promotor.
